Aim and nature of the course

The course lasts for a year and it intends to respond to the urgent necessity of preparing ministers of the law for the following principal purposes:

- immediate integration into the various roles of the ecclesiastical tribunals;
- service in the diocesan curia and/or in the Institutes of Consecrated Life and Societies of Apostolic Life; and
- eaching of Canon Law in the seminaries and in the Higher Institutes of Religious Science.

Structure of the Course

Apart from the general aspects, the course is distributed in four specific subjects with their specific lessons.

The language of the lessons is Italian.

- licentiate or doctorate degree in Canon Law;
- · authorisation from the competent ecclesiastical authority;
- enrolment fee.

Students who complete the course and satisfy the required conditions are awarded a diploma in Ecclesiastical Praxis and Jurisprudence; for students who continue their studies up to the doctorate, it is possible to obtain a degree in Canon Law with a specialization in Praxis and Ecclesiastical Jurisprudence, if they choose this subject as the theme of their research.


